Introduction

This university is consisted of nine faculties where around 7000 students study in around 27 programs. The present Internal Quality Assurance Five Years Strategic Plan is made to support what is already said. Institutional Background

Alberoni University is located in Kohistan, one of the districts of Kapisa province in central Afghanistan. It is located in a distance of about 64 km far away from the capital Kabul. Alberoni University is a public university which was inaugurated in 1998 with the motto of “bringing excellence in education to Afghanistan”. Alberoni University started with a faculty of medical and engineering, but now it is the biggest university after Kabul, Nangarhar, Balkh and Herat universities. At the moment Alberoni University has nine faculties and about 32 departments. Around 4682 students are taught in undergraduate programs by 147 faculty members at Alberoni University. Languages and Literature, Medical, Engineering, Education, Economics, Law and Political Science, Journalism, Agriculture and Sharia Law are the nine faculties of Alberoni University.

Alberoni University strives to serve the public and is dedicated to building a prosperous and well educated society by generation of knowledge through conducting research, dissemination of knowledge through training, and to advancing application of knowledge in private and public sectors. Alberoni University is trying to build its institutional development more efficiently and effectively. Alberoni University has access to about appropriate facilities and equipment in order to realize its commitments: a new campus, modern and beautiful buildings for its three faculties, advance laboratories for medical, engineering and education faculties, rich libraries, well equipped lecture rooms, and most importantly, capable lecturers who make this university a superior institute.
